2. The Model, the person in part referred to in this document, consents to being a subject of the Artist in media. The Model will allow the Artist to capture images, sound recordings, and other identifiable likenesses including artistic creations and derivatives for use in media.

External transactions undertaken for financial reward will result in the Model being awarded a sum equal to 25% of the total net profit margin of any and all such transactions.

The Model shall be responsible for any taxes, duties and other costs payable. The group will guide and mentor the Model on these matters upon written request including requests for withholding partial sums or the full sum for specific periods of time or for a specific purpose.

Monthly statements are provided which show investment results and available balance(s).

A further 10% of the remaining 75% (7.5%) shall be put aside in a fund specifically operated for the benefit of Models or students or either, known as the JEG Benefit Fund, with limited financial means who would otherwise be unable to compete for placements despite having the talent to do so due to their restricted access to funds. No other options exist for access to this fund.

### OTHER USES OF MEDIA:

Where proposed uses of media are not covered by this document, it may be extended by mutual agreement to include such a use, or the Model may request a formal document to be created to cover specific circumstances.

One example of "other uses" within this context is the appearance of the Model as a vocalist at a music festival.
